Sealed Quotations are invited in an envelope indicating "Quotation for Empanelment of Outsource Agency" containing two separate sealed envelopes of 'Technical Bid' and 'Financial Bid'. The performa of Technical Bid and Financial Bid are attached herewith.

Scope of work : Approx. 50 to 100 engagements likely to be assigned during the contract period which may be increased or decreased substantially as per requirement. Successful bidder may also be allotted work of various societies under the chairmanship of Deputy Commissioner, Bhiwani.

Terms and Conditions

- Only agency fulfilling the Government norms like Registration number, Service Tax No, EPF, ESI, PAN need to apply.
- The firm/company should be licence holder under the Contract Regulation and Abolition Act, 1970.
- Agency should have at least three years experience in Government sector with minimum 100 employments in an year.
- The successful bidder will sign the agreement as per the outsourcing policy of Government of Haryana.
- The contract can be cancelled if any irregularity or unsatisfactory performance found during the contract period.
- The manpower will be hired on DC rates and other provisions like ESI, PF, Maternity benefits etc.
- The agency shall make all payments through bank only. Non compliance will attract penalty.
- The agency shall provide the copies of all types of deposits i.e. EPF/ESI. Non compliance will attract penalty as per applicable rules and regulations.

- **Period of Contract :** Six months from the date of agreement may be renewed further from time to time on satisfactory performance.
